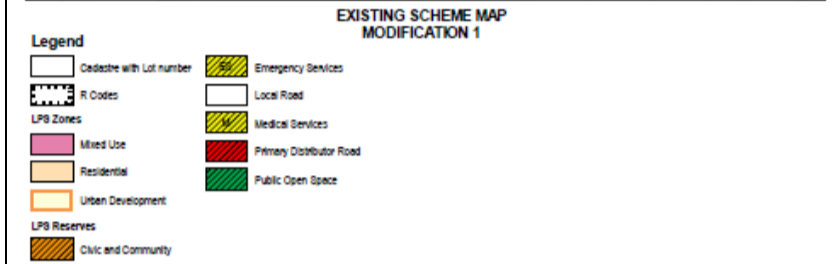
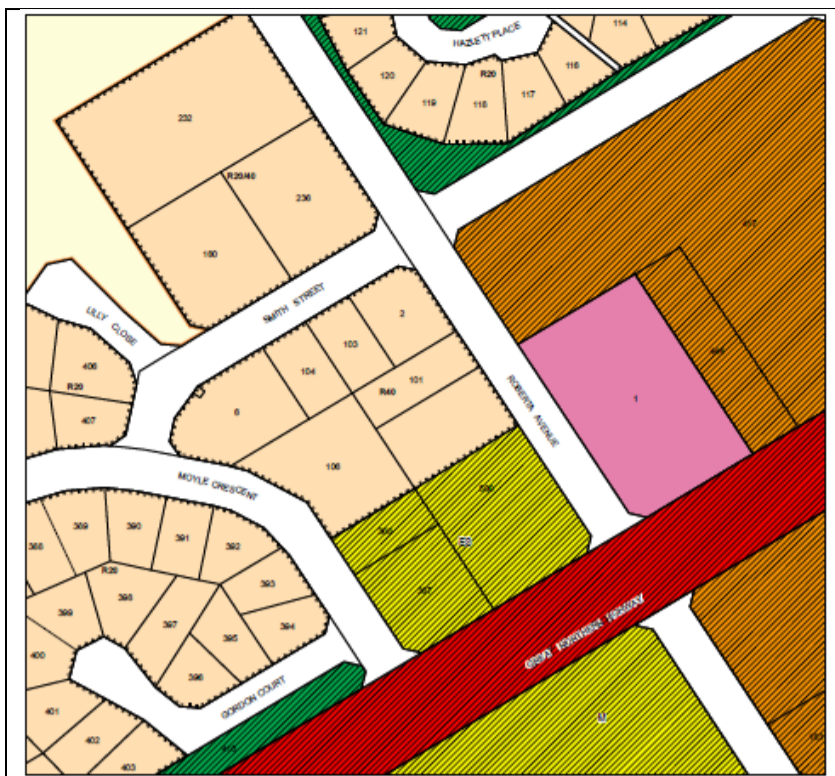


Figure 1 Modification No. 3.1

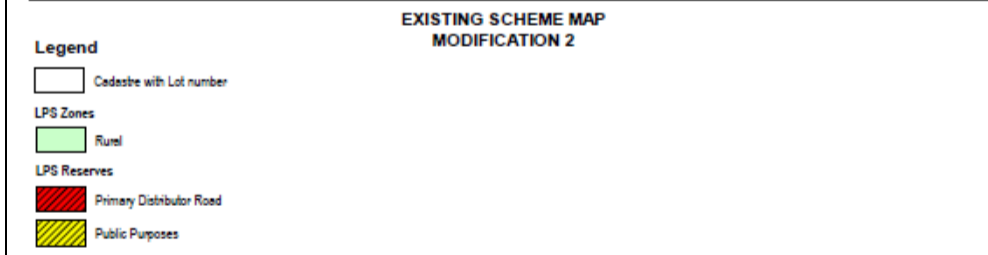
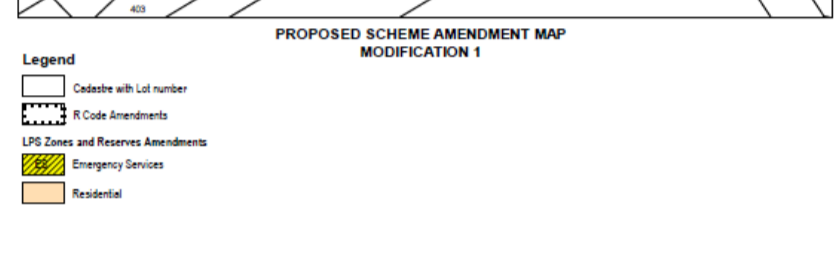
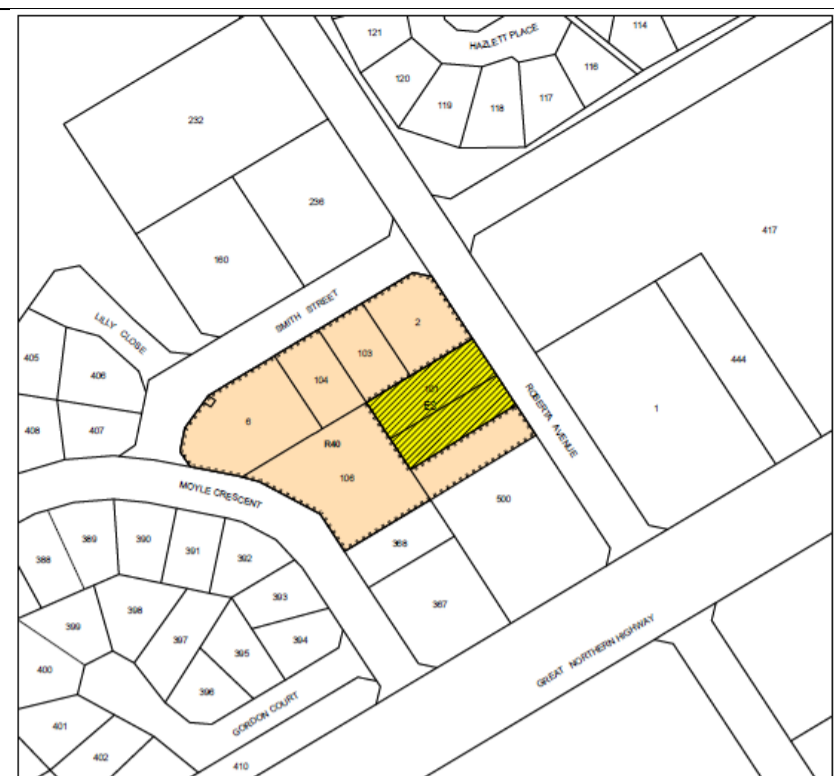
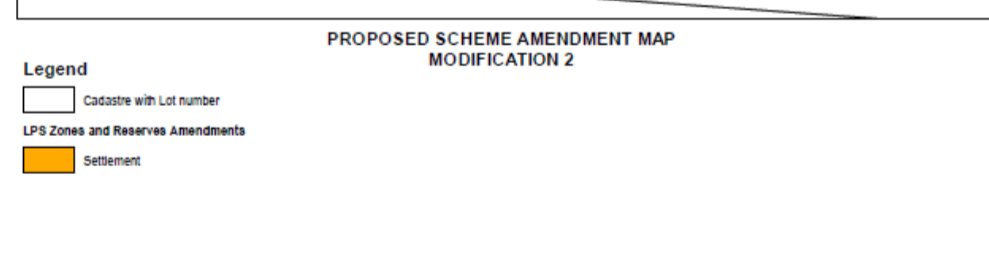


Figure 2 Modification No. 3.2

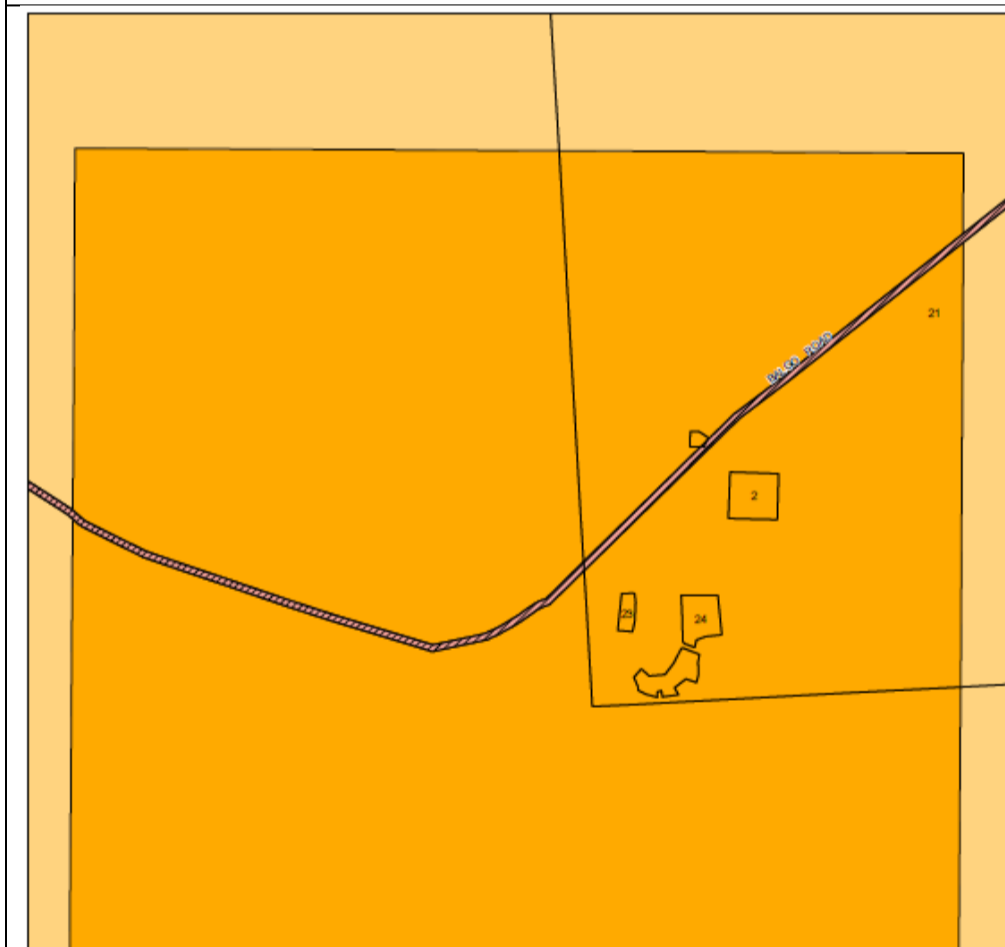

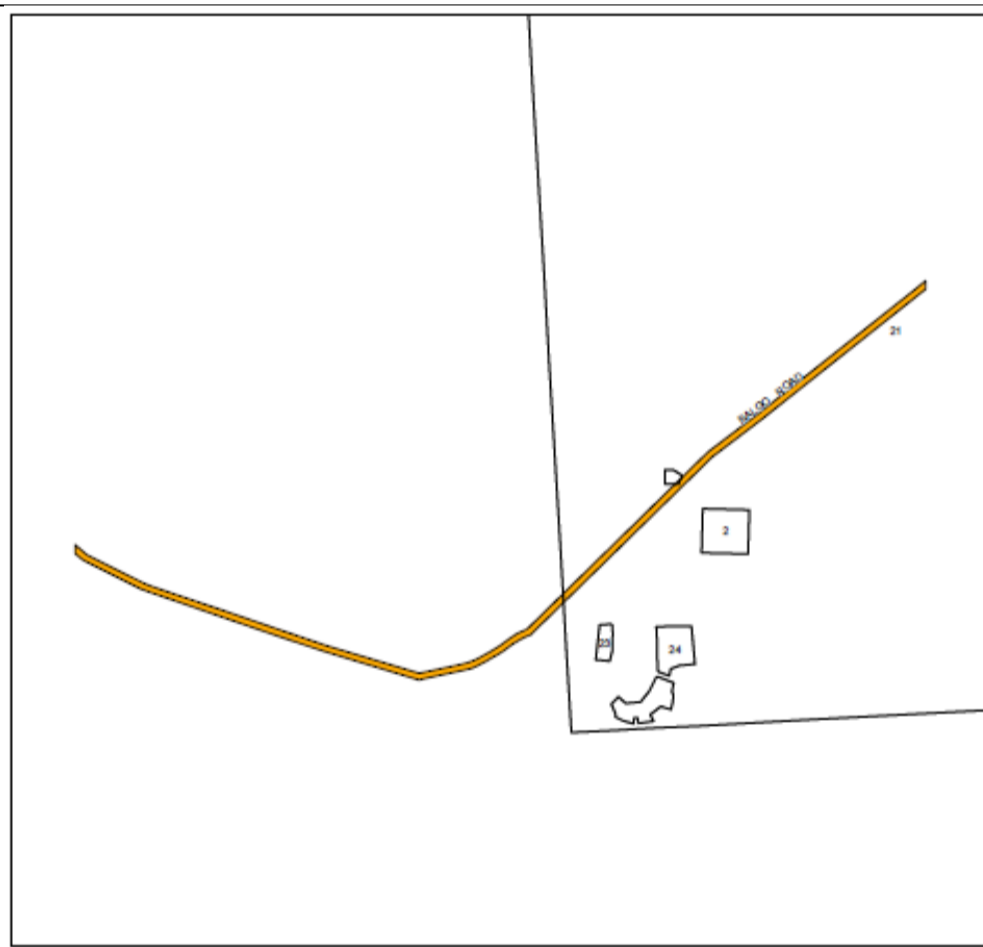

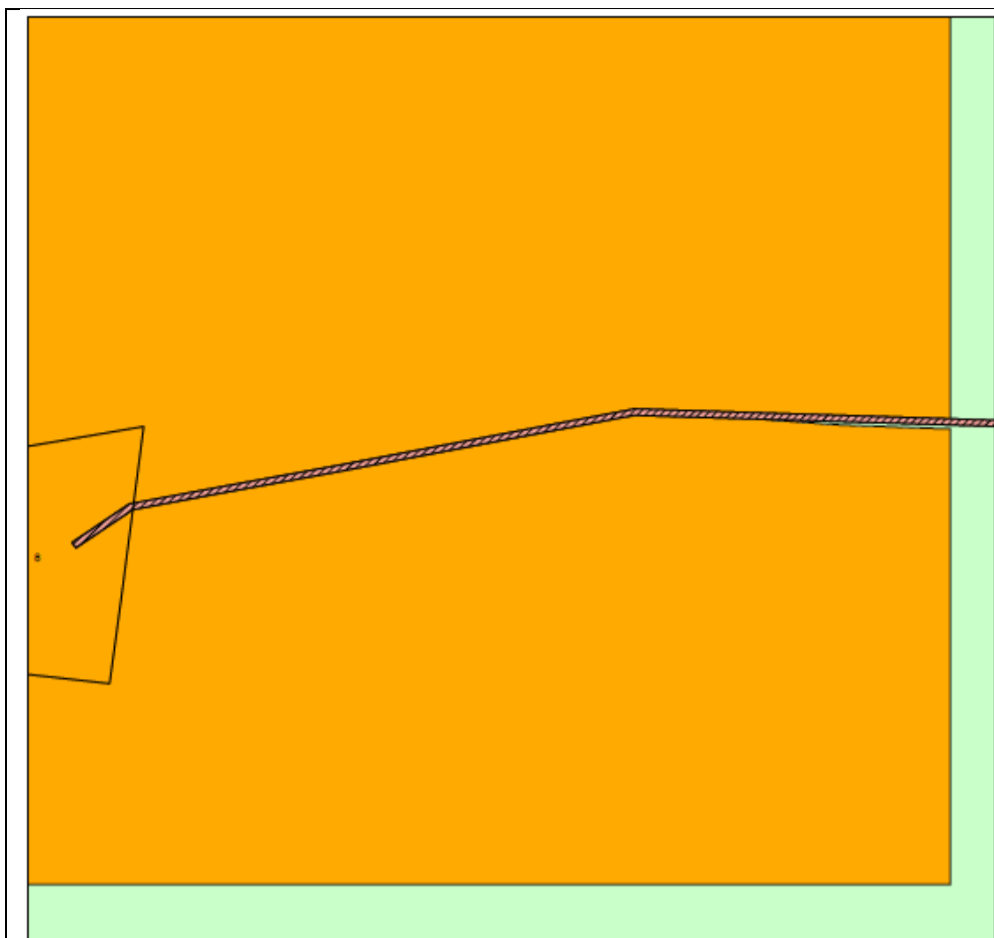

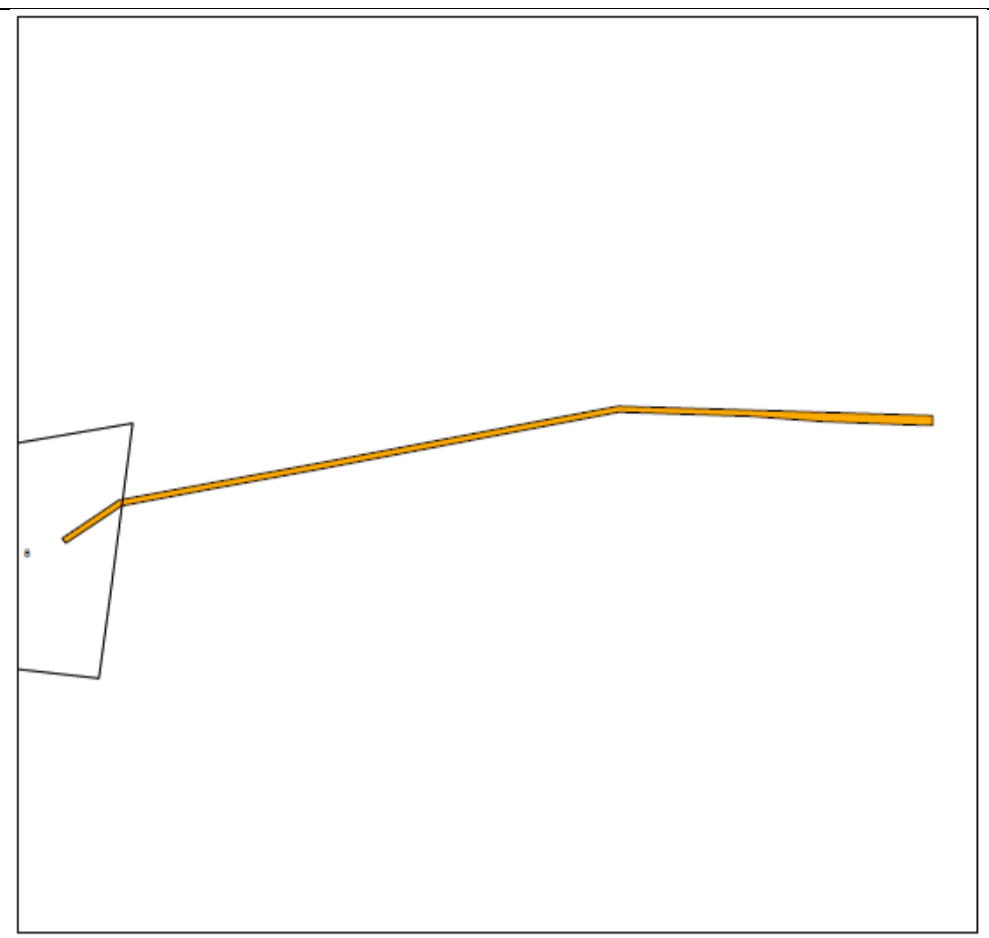
Figure 4 Modification No. 3.4

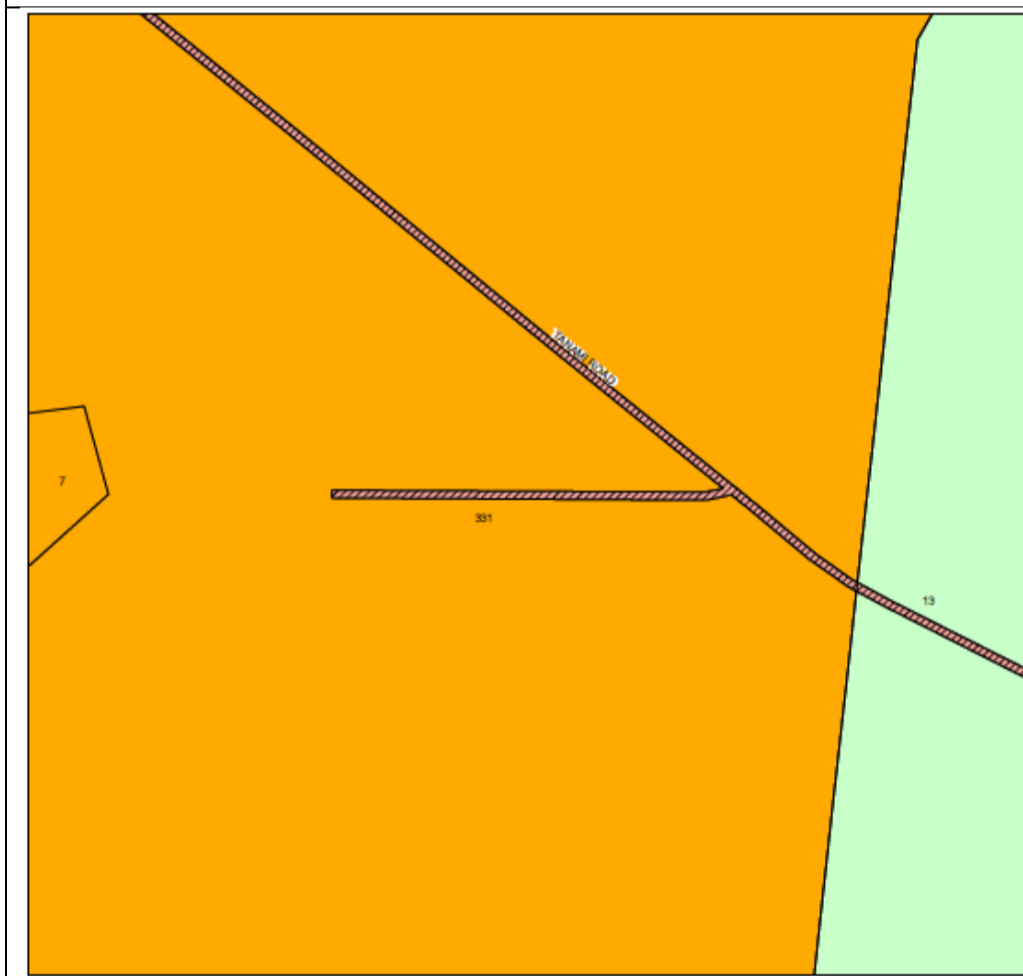

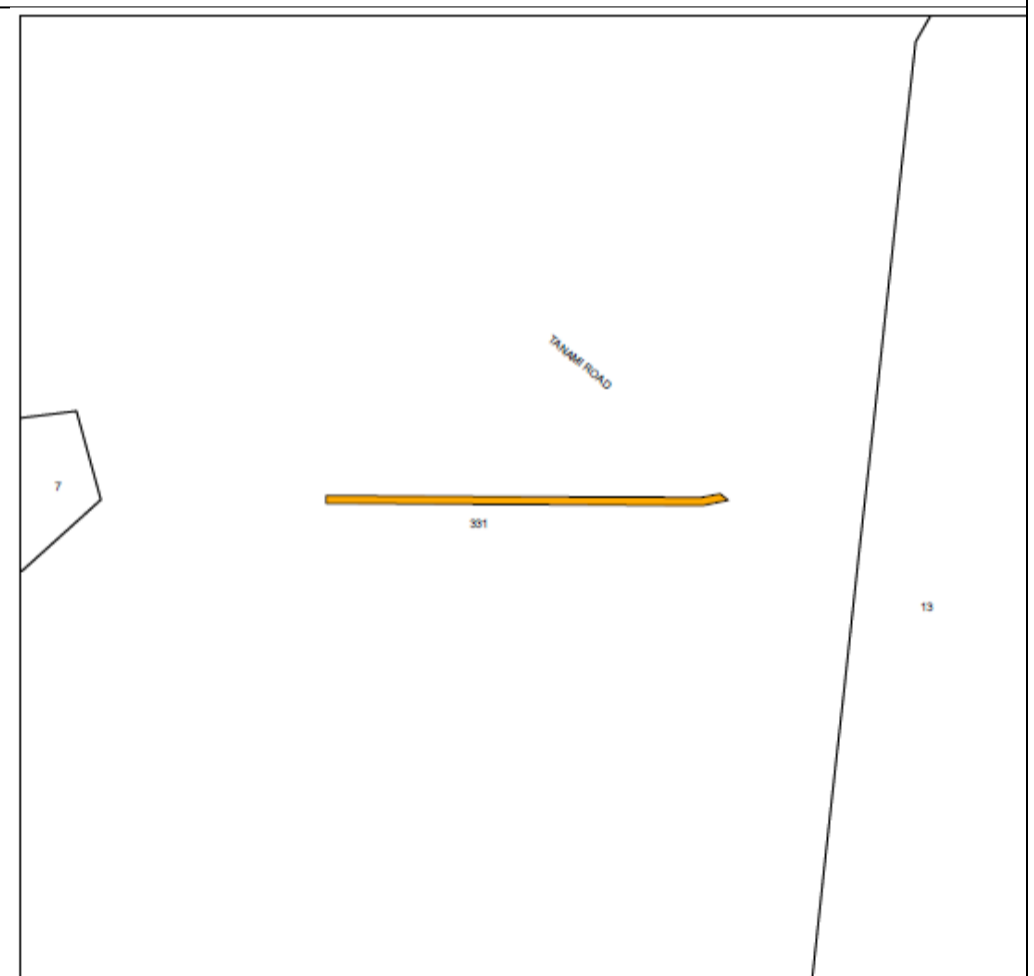

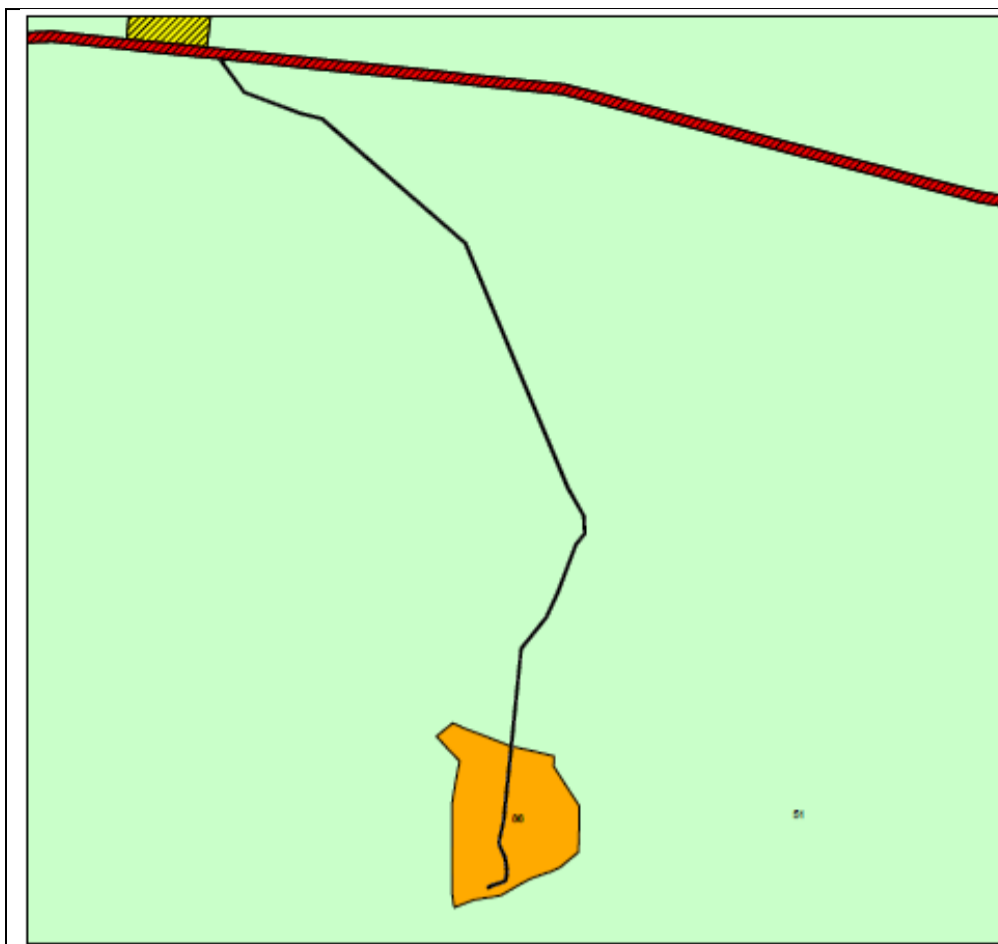

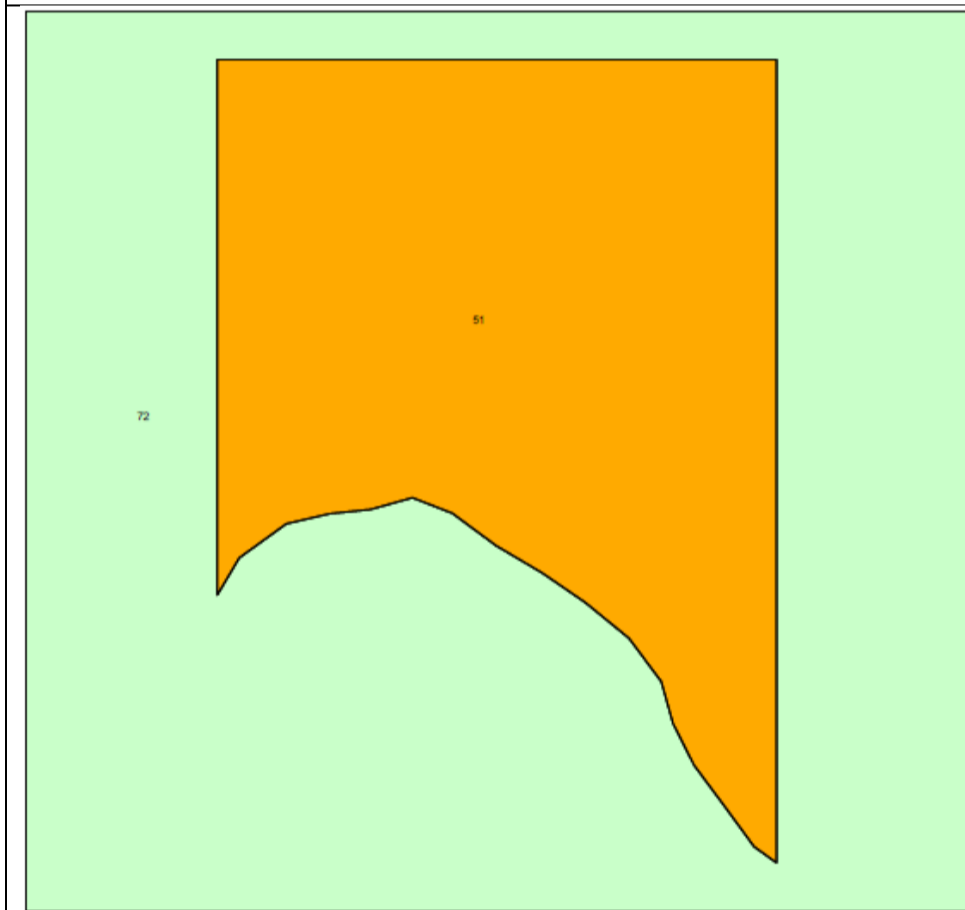

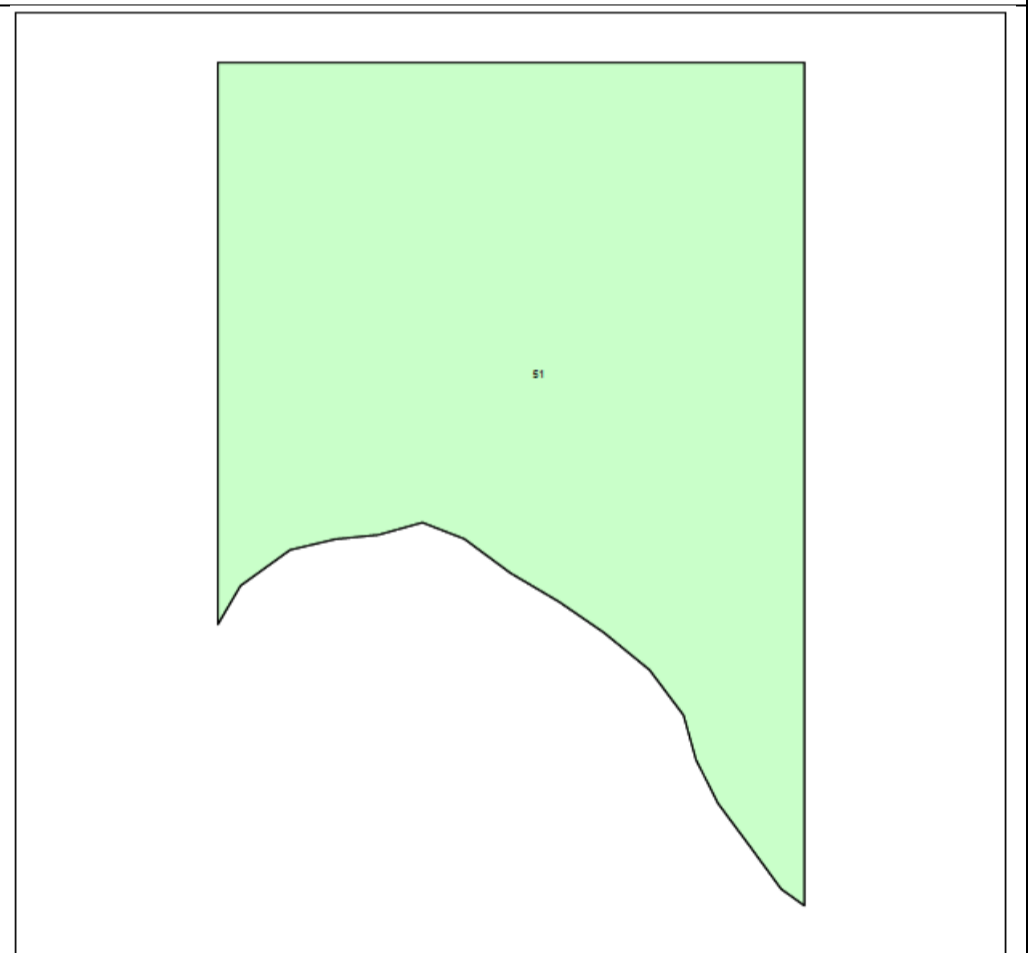
